

School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

NOTE: There is no required format for written expectations; this is a sample of what might be included.

The Lincoln Elementary School agrees to implement the following statutory requirements:

 - *Distributing parental surveys at fall parent-teacher conferences.*

3. The **Lincoln Elementary School** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

- *Holding the Title One informational meeting during Meet the Teacher night on September 2, 2010.*
 - *Holding an additional meeting after the completion of school-wide fall testing, if needed.*
 - *Informing parents unable to attend the Title One Informational meeting that they may set up an individual meeting or phone conference with Mrs. Henneise, the Literacy Coordinator, at a time convenient to both parties.*
4. The **Lincoln Elementary School** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
- *Holding the Title One informational meeting during Meet the Teacher night on September 2, 2010.*
 - *Having Mrs. Henneise available for conferences during all district parent-teacher conference days.*
 - *Sending home progress monitoring data at least once a grading period to parents with students receiving Title One reading services.*
 - *Sending home a letter explaining how to read the progress monitoring data with all progress monitoring data.*
5. The **Lincoln Elementary School** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
- *Scheduling IAT (RtI problem solving) meetings*
 - *Holding parent-teacher conferences*
 - *Arranging for meetings with the classroom teacher and/or literacy coordinator*
 - *Emailing information to parents*
 - *Sending home notes and progress monitoring to parents*
 - *Discussing suggestions, decisions, and concerns over the phone*
 - *Holding phone conferences*
6. The **Lincoln Elementary School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
- *Sending home ISAT and benchmark testing data at parent-teacher conferences*
 - *Scheduling parent-teacher conferences for teachers to explain and provide the state assessment results to parents.*

7. The **Lincoln Elementary School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- *Sending home a letter from the district office to parents.*

8. The **Lincoln Elementary School** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

(List activities, such as workshops, conferences, classes, both in-state and out-of-state, including any equipment or other materials that may be necessary to ensure success.)

- *Sending home ISAT and benchmark testing data at parent-teacher conferences*
- *Scheduling parent-teacher conferences for teachers to explain and provide the state assessment results to parents.*
- *Sending home progress monitoring data at least once a grading period to parents with students receiving Title One reading services.*
- *Sending home a letter explaining how to read the progress monitoring data with all progress monitoring data.*
- *Holding the Title One informational meeting during Meet the Teacher night on September 2, 2010.*
- *Holding a reading night for parents at least once during the school year.*

9. The **Lincoln Elementary School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- *Holding the Title One informational meeting during Meet the Teacher night on September 2, 2010.*
- *Holding a reading night for parents at least once during the school year.*
- *Posting information about reading with children on the school's website.*
- *Holding parent-teacher conferences throughout the year.*

10. The **Lincoln Elementary School** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- *Holding staff meetings involving this material.*
- *Requesting feedback from parents on surveys at fall parent-teacher conferences and on the mid and end of year Title One surveys.*
- *Requesting input for the parental involvement policy at the Title One Informational meeting.*

11. The **Lincoln Elementary School** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

- *Holding the Title One informational meeting during Meet the Teacher night on September 2, 2010.*
- *Holding a reading night for parents at least once during the school year.*
- *Posting information about reading with children on the school's website.*
- *Holding parent-teacher conferences throughout the year.*

The **Lincoln Elementary School** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- *Sending home ISAT and benchmark testing data at parent-teacher conferences*
- *Scheduling parent-teacher conferences for teachers to explain and provide the state assessment results to parents.*
- *Sending home progress monitoring data at least once a grading period to parents with students receiving Title One reading services.*
- *Sending home a letter explaining how to read the progress monitoring data with all progress monitoring data.*
- *Using translating software and Internet sites to translate material for parents, if needed.*
