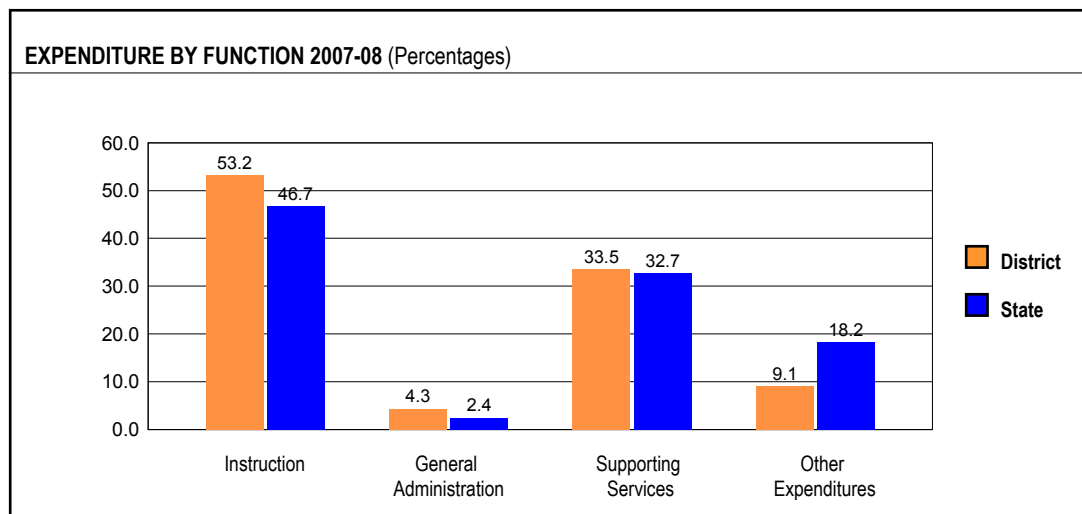

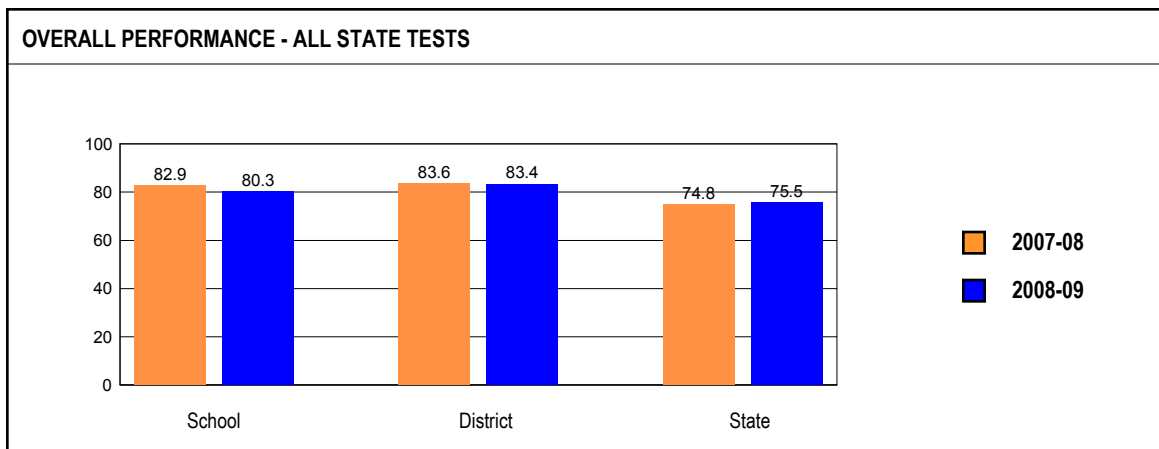

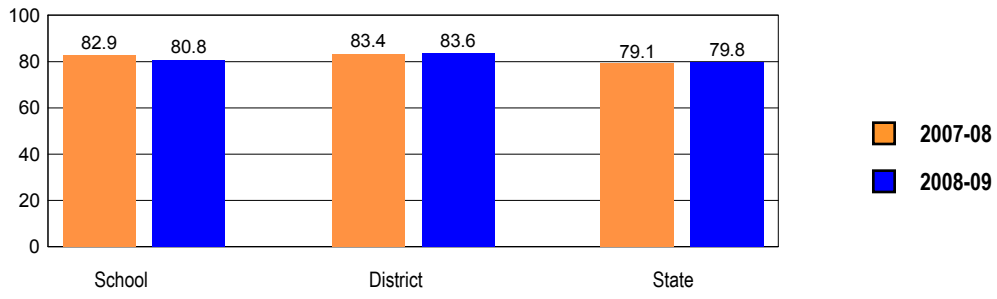
OVERALL STUDENT PERFORMANCE

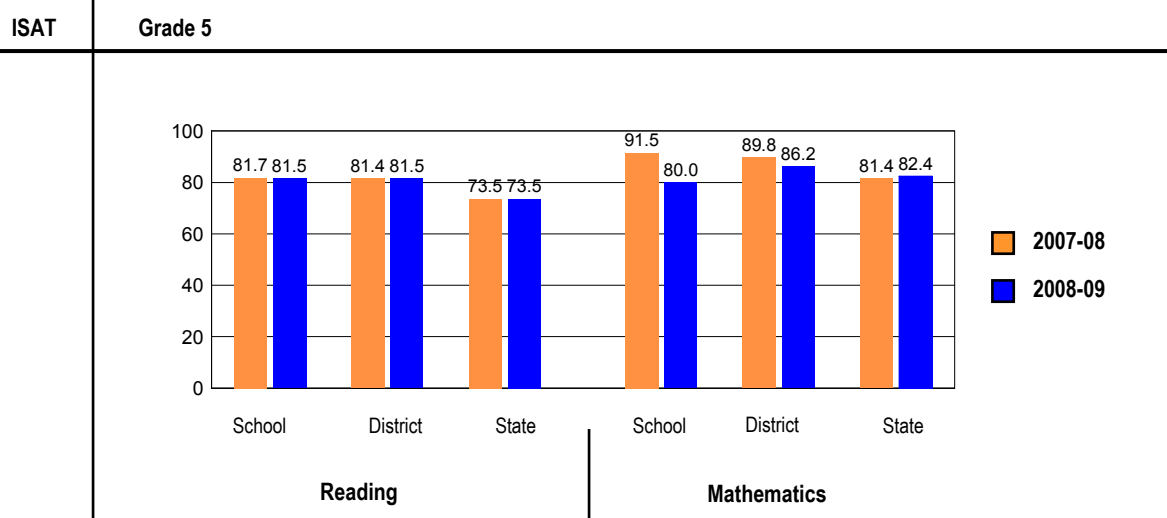
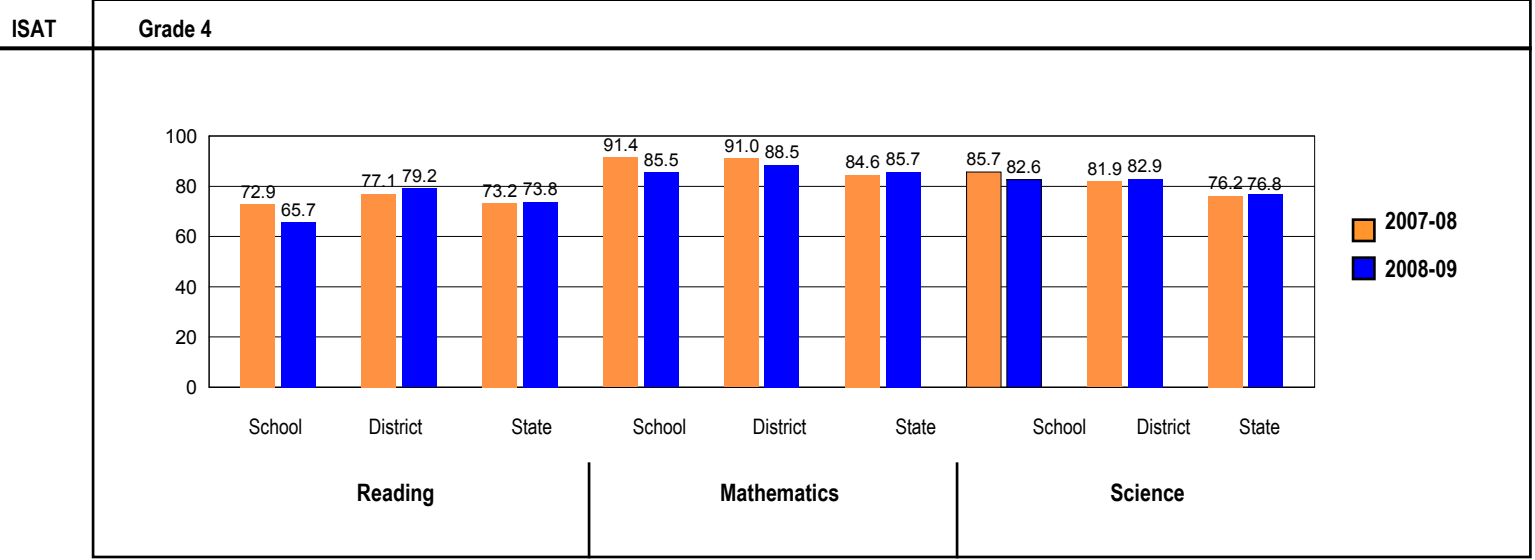
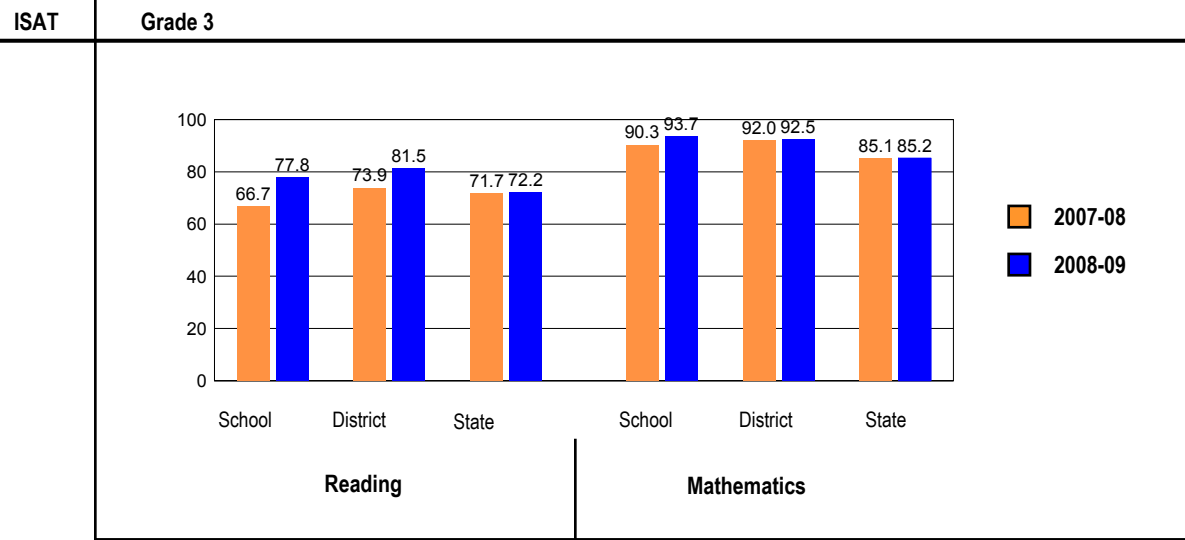


OVERALL ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT) PERFORMANCE

PERFORMANCE ON STATE ASSESSMENTS

Federal law requires that student achievement results for reading, mathematics, and science for schools providing Title I services be reported to the general public.

The Illinois Standards Achievement Test (ISAT) is administered to students in grades 3 through 8. The Prairie State Achievement Examination (PSAE) is administered to students in grade 11. The Illinois Alternate Assessment (IAA) is administered to students with disabilities whose Individualized Education Programs (IEPs) indicate that participation in the ISAT or PSAE would not be appropriate.

Students with disabilities have an IEP (No Child Left Behind Act). An IEP is a written plan for a child with a disability who is eligible to receive special education services under the Individuals with Disabilities Education Act.

Reading and Mathematics are tested in grades 3 through 8 and 11. Science is tested in grades 4, 7, and 11.

In order to protect students' identities, test data for groups of fewer than ten students are not reported.

ILLINOIS STANDARDS ACHIEVEMENT TEST (ISAT)

The following tables show the percentages of student scores in each of four performance levels. These levels were established with the help of Illinois educators who teach the grade levels and learning areas tested. Due to rounding, the sum of the percentages in the four performance levels may not always equal 100.

Level 1 -- Academic Warning - Student work demonstrates limited knowledge and skills in the subject. Because of major gaps in learning, students apply knowledge and skills ineffectively.

Level 2 -- Below Standards - Student work demonstrates basic knowledge and skills in the subject. However, because of gaps in learning, students apply knowledge and skills in limited ways.

Level 3 -- Meets Standards - Student work demonstrates proficient knowledge and skills in the subject. Students effectively apply knowledge and skills to solve problems.

Level 4 -- Exceeds Standards - Student work demonstrates advanced knowledge and skills in the subject. Students creatively apply knowledge and skills to solve problems and evaluate the results.

Areas of success for Lincoln School

Lincoln School students have been well above the expected levels of Exceeds and Meets on ISAT in the area of Math. All grade levels and subgroups continue to meet AYP in Math with 3rd Grade at 93.7 % of students Exceeding or Meeting standards, 4th Grade at 88.5 % of students Exceeding or Meeting standards and 5th Grade at 80% of students Exceeding or Meeting state standards.

Students in 5th Grade during the 2008-2009 year also improved in the percentage of students Exceeding and Meeting state standards in Reading. There was a percentage increase of 8.6%age points going from 72.9% of students in their 4th Grade year (2007-2008) Exceeding or Meeting standards to 81.5% of the same students in their 5th Grade year (2008-2009) Exceeding or Meeting state standards.

Lincoln School 4th Graders are also above the state average scores for Exceeds and Meets in the area of Science. In 4th Grade 82.6% of the students were Exceeding or Meeting the state standards.

Areas in need of improvement for Lincoln School

Reading is an area where improvement is needed. At the 4th Grade level, 65.7% of students Exceeded or Met state standards in Reading. This same group of students performed at a lower level in reading as 3rd Graders.

All children will be in the regular curriculum for reading for exposure to the general education curriculum. It is suspected that while some students are still functioning below grade level in reading they may be missing some critical skills that are taught and tested on ISAT by being a part of a pull out program. Children who are functioning below grade level in reading will receive intervention services at a time other than the time of the instruction for the general curriculum.

Teachers will receive professional development in the areas of Reading and Writing to assist them in helping students achieve at higher levels.
